3:30 p.m. This is the time set for a telephonic pretrial conference before Special Water Master Susan Harris to address any procedural issues about the evidentiary hearing.

Discussion is held regarding procedural issues including initial and final disclosure deadlines, potential witnesses, exhibits, and expert reports.

Mr. Hood states that he anticipates the trial will last one to two weeks. He anticipates that the first witnesses will be witnesses called by Arizona Department of Water Resources.

Ms. Brennan states that the Land Department does not intend to call any witnesses.

Ms. Parks advised that the ADWR has not designated witnesses yet.

Mr. McGinnis said that he expects that between five and ten witnesses will be closed. He suggested November 30, 2020 for disclosure statement. Unresolved are the rules about how direct testimony shall be handled.

Mr. Hood requests direct examination in addition to submission of expert reports into evidence subject to non-hearsay objections.

Mr. Burnside states that APS will be calling a witness and requests that a reasonable amount of direct examination should be allowed.

Ms. Herrmann said that the San Carlos Apache Tribe expects calling one or two witnesses.

Ms. Ransom said that the City of Sierra Vista and Pueblo del Sol will be calling one or two witnesses. She states that a November 30th date for disclosure is too late given anticipated discovery schedule.

Mr. Murphy states that the Gila River Community may call a rebuttal witness.

Further discussion is held regarding the evidentiary hearing and trial schedules. Counsel agree to the setting of another status conference before trial to further discuss procedural issues and scheduling matters.

Mr. Burnside states that given the discovery deadline he does not see a better date than the end of December 2020 for final disclosures.
