The following attorneys appear telephonically: Mark McGinnis on behalf of SRP; Joe P. Sparks on behalf of the San Carlos Apache Tribe and the Tonto Apache Tribe; Brad Pew on behalf of ASARCOS; John Burnside on behalf of BHP Copper; Kimberly Parks on behalf of the Arizona Department of Water Resources (ADWR); Jay Brown on behalf of the St. David Irrigation District and Bill Dawson who is appearing for Daniel Stadtler in an unofficial capacity. Neither Robert nor Janet Overson are present or represented by counsel.

A record of the proceedings is made digitally in lieu of a court reporter.

This parcel is owned by Mr. Stadtler, the Oversons, and the Successors in Interest to Riley Lake Holding LLC.

Mr. Brown advises the Court that the parcels in this case which are owned by the Womacks and the Rodney and Sharon Xanthos Revocable Trust are part of the St. David Irrigation District and should be part of that case.

The Court designates the case as a Track 1 case and directs ADWR to schedule a meeting with Mr. Stadtler, his representative and the objectors.

Mr. Sparks suggests that the meeting to be held with ADWR on this parcel coincide with the other parcels owned by Mr. Stadtler as well.

A meeting will be held by ADWR with Mr. Stadtler, Mr. Dawson, and other objectors in both this case and W1-11-1691.

IT IS ORDERED joining the claims associated with the land owned by Lavon Womack, Rebecca Womack and Rodney and Sharon Xanthos as Trustees of the Xanthos Revocable Trust, dated January 18, 2003 and included in Watershed File Report 112-17-BAD-016 are consolidated with *In re St. David Irrigation District*,

LATER:

IT IS FURTHER ORDERED that ADWR shall schedule and hold a meeting pursuant to Rules for Proceedings Before the Special Master §8.02[1] on or before February 28, 2019 with Mr. Stadtler, his representative and the objectors to address objections to claims for water rights identified in Watershed File Report 112-17-BAD-016 with respect to land owned by Mr. Stadtler individually or in trust. The meeting shall also include the parties involved in contested case W-11-1917.

To facilitate discussions at the meeting, all parties are directed to bring to the meeting any deeds, aerial photographs, wells logs and other documents that are readily available to the party and relevant to the ownership of the land and past and present irrigation on the land.
