The following attorneys and parties appear telephonically: David A. Brown; John Burnside on behalf of BHP Copper; F. Patrick Barry and Yosef Negose on behalf of the United States Department of Justice; Laurel Herrmann and Joe Sparks on behalf of San Carlos Apache Tribe and Tonto Apache Tribe; David Jacobs on behalf of the Arizona State Land Department; Kimberly Parks on behalf of Arizona Department of Water Resources; Jay Tomkus on behalf of Pascua Yaqui Tribe and Yavapai-Apache Nation; Sharon Morris on behalf of Salt River Project; and Thomas Murphy on behalf of the Gila River Indian Community.

Court reporter, Lydia Estrada-Gray, is present and a record of these proceedings is made digitally.

Mr. Caster requests six months to amend ASARCO's statements of claimant (SOCs). He responds to the Court's questions regarding the amount of work needed amendments.

**IT IS ORDERED** granting ASARCO's request to amend the SOCs. The amended SOCs are to be filed by January 7, 2019. The SOCs are to identify the legal owners of the land, GPS locations of wells, include a map that shows the location of the wells relative to the subflow zone, and list the beneficial water uses.

IT IS FURTHER ORDERED in regards to SOCs that haven't been assigned from Kennecott Copper, ASARCO is directed to produce an assignment or obtain an assignment from the original claimant to ASARCO or provide an explanation of reasons that an assignment cannot be obtained.

ASARCO will identify the correct parties that need to be involved in the adjudication of the water rights listed in the applicable HSR.

The Court notes that once the above-referenced amendments have been completed, this will be a Track 2 case.

Mr. McGinnis and Mr. Sparks respond with their respective positions and support the grant of an extension of time to file amended statements of claimant.

Mr. Jacobs advises the Court that the Arizona State Land Department has only an interest in the irrigation case.

Mr. Caster responds to the Court's question whether the cases should be consolidated or kept separate and requests that the cases not be consolidated at this time.

**IT IS FURTHER ORDERED** that a status conference will be set in February 2019 in which the parties will decide from there on how to proceed based on the objections.
