On June 16, 2020, the Arizona Department of Water Resources (ADWR) filed its Meeting Report stating that landowners Helidoro Lerma and Francisco and Anna Estrada had the opportunity to meet with ADWR and representatives of many of the entities that filed objections to Watershed File Report 114-04-DBC-006 prepared by ADWR in 1991.

1 According to the Meeting Report, the original statement of claimant filed by Manuela Franco
2 has not been assigned but Frank and Anna Estrada filed Statement of Claimant 39-18082 to claim
3 two acre-feet of water per year for domestic use. The Meeting Report also indicated that Helidoro
4 Lerma and Roberto Chavez do not intend to pursue a claim for a water right.

5
6 **IT IS ORDERED** that a status conference and hearing shall be held to determine:

7 1. If Francisco and Anna Estrada have obtained an assignment of the Statement
8 of Claimant filed by Manuela Franco.

9 2. If an assignment has not been obtained, whether good cause exists to dismiss
10 the Statement of Claimant filed by Manuela Franco.

11 3. Whether the proposed abstract that will be prepared by Francisco and Anna
12 Estrada sets forth a claim for a water right that qualifies as a *de minimis* water right.

13 4. Whether any objector has any comments with respect to the abstract that will
14 be prepared by Francisco and Anna Estrada and mailed to all parties listed on the court
15 approved mailing list no later than **July 31, 2020** and filed with Clerk of the Maricopa County
16 Court.

17 5. The abstract that is filed with the Clerk of the Maricopa County Court shall
18 have a cover sheet that identifies this case by the contested case number and contested case
19 name shown on the first page of this order.
