On August 28, 2018, an order was issued that listed information to be provided by the

3 IT IS ORDERED that by February 28, 2019, the Landowner shall file with the Court  
4 the following documents:

6 1. The map prepared by ADWR of the Landowner's property filed August 20, 2018,  
7 that has been completed by the Landowner with the GPS coordinates for the corners  
8 of the irrigated property;
- 9  
10 2. A statement that reports the amount of irrigated acreage to be allocated between the  
11 land located in Section 34 T 6S R17E and in Section 3 T 7S R17E;
- 12  
13 3. Documentation supporting a claimed basis and priority date for the irrigation of the  
14 land in Section 3 T 7S R17E;
- 15  
16 4. The GPS coordinates for the well;
- 17  
18 5. The maximum diversion rate of water from Aravaipa Creek.

20 Attachment A.
