As shown by the map prepared by Arizona Department of Water 28

Resources ("ADWR") filed May 18, 2020, the trustees of the Zachek Family Trust currently own this land. A copy of the map that shows all of the land included in the boundaries of Watershed File Report 115-05-048 is attached as Attachment A. In accordance with expedited procedures adopted to determine water rights in the San Pedro watershed for *de minimis* stock watering uses, a proposed abstract has been prepared for review and mapping by ADWR. The proposed abstract is attached as Attachment B.

Magoffin Family Trust




Figure 1. Land owned by Magoffin Family Trust investigated by Watershed File Report 115-05-048 is located in the northwest quarter of the northeast (NWNE) quarter of Section 27 T 07S R20E.

The land owned by the trustees of the Magoffin Family Trust that is included within the boundaries of Watershed File Report 115-05-048 is located wholly within the northeast quarter of section 27 T7S R20E. See figure 1.

The trustees of the Magoffin Trust claim a right to water for a stockpond in the northeast quarter of Section 27 in Statement of Claimant 39-18168. They also filed Statement of Claim 36-105971 for stock and wildlife watering in the northeast quarter of Section 27. A draft abstract is attached as Attachment C based on the discussion of the parties at the Status Conference on March 5, 2021 about a stockpond for which Mrs. Magoffin stated she is asserting a claim in lieu of making a claim for water to irrigate three acres in Section 27.

Subsequent to the Status Conference, Mrs. Magoffin filed a form of abstract with a proposed water right number 115-05-048-SP003 for a stockpond located in the southeast quarter of section 27 T7S R20E and referenced Certificate of Stockpond Water Right No. 38-96721 for Haby Pond. The Certificate of Stockpond Water Right 38-96721 identifies Haby Pond as located in the southwest quarter of section 27 T7S R20E. A copy of the Certificate of Stockpond Water Right is attached as Attachment D.

IT IS ORDERED that ADWR shall review the draft abstract for stock and wildlife watering use and provide the parties in this case with its comments along with a map that shows the location of the stock watering use by June 18, 2021.

IT IS FURTHER ORDERED that ADWR shall review the draft abstract for a water right for a stockpond use and provide the parties in this case with comments along with a map that shows whether a stockpond exists within the boundaries of the land investigated by Watershed File Report 115-05-048 that is owned by the trustees of the Magoffin Family Trust. A report shall be filed by ADWR by June 18, 2021.

IT IS FURTHER ORDERED removing Claridge Hugh & Sons and Patricia Hughes from the court approved mailing list. Court documents sent to the last known address for these claimants have been returned with no forwarding address.
