The Court notes that the Salt River Project (SRP) has filed extensive objections to potential water rights for irrigation use for Pima County.

Michael Foy states that he is willing to meet with representatives from Pima County to work out a process to address the resolution of SRP's objections to potential water rights (PWR) for irrigation use in Watershed File Report 113-12-BD-002.

The Court further notes that the San Carlos Apache Tribe and Tonto Apache Tribe have also filed objections.

Laurel Herrmann states that objections were filed a long time ago and she does not know what the objections are at this time. She indicated that she has a public record request with the Arizona Department of Water Resources. She would like to be included in the discussion with Pima County and SRP.

Carrie Brennan addresses the Court concerning a section of land that appears to belong to the Arizona State Land Department identified in Watershed File Report 113-09-020, Statement of Claimant no. 39-2771. Discussion is held.

The Court directs Ms. Brennan to submit a report by February 26, 2018 concerning the ownership of SESW Sec. 7 T11S R18E, which is the reported place of use for PWR113-09-020-SW002.
