General Explanation

This Order begins the process necessary to adjudicate claims made for rights to appropriable water for use on land that the Cochise County Assessor has identified as owned by David E. Johnson. This contested case is one of the many cases in the Arizona General Stream Adjudication for the San Pedro River Watershed to determine legal rights to water. Other cases in which claims have been made for legal rights to water in the San Pedro River Watershed have

1 been completed, are in the process of determining water rights, or are awaiting initiation. The
2 purpose of the General Adjudication is to determine the rights of those persons who filed
3 Statements of Claimant for rights to use appropriable water in Arizona. The General
4 Adjudication will also determine water rights in the Upper Salt, Verde, Upper Gila, Lower Gila,
5 Agua Fria, and Upper Santa Cruz watersheds.

6
7 In this case, Richard A. and Reva Kirkman (“Claimant”) filed Statement of Claimant
8 (“SOC”) 39-6110 on June 30, 1980, for rights to water for use on land described as Lot 53,
9 Cochise Ranchos in Cochise County. The Arizona Department of Water Resources (“ADWR”)
10 investigated the claim, which it characterized as a claim for irrigation and domestic uses, and
11 prepared a report known as Watershed File Report No. 112-20-BC-271 (“WFR”) published in
12 the Final San Pedro River Watershed Hydrographic Survey Report (1991). A copy of the WFR
13 is attached as Attachment A.
14

15 The SOC includes claims for future use of water for irrigation and domestic use from a
16 well located in Section 13 T20S R19E. The WFR found no irrigation or domestic watering uses
17 on the land described in the WFR. After ADWR issued the WFR, objections were filed to the
18 findings made in the WFR. The purpose of this case is to consider the claims made for water
19 rights that are the subject of the WFR and resolve the objections to the WFR.

22 **Claimant & Landowners**

23 The WFR identified one SOC relevant to the potential water right: 39-6110. Richard A.
24 and Reva Kirkman. filed the SOC claiming water for irrigation and domestic uses. The WFR
25 lists Richard A. and Reva K. Kirkman as the owners of the property described as located Section
26 13 Township 20S Range 19E. The records of the Cochise County Assessor indicate that David
27 E. Johnson is the owner of the land described in the WFR. David E. Johnson owns tax parcel no
28

1 106-05-005. The public records of the Arizona Department of Water Resources do not contain an
2 assignment of the SOC from Richard A. and Reva K. Kirkman to any successor landowner. A
3 copy of the map prepared by the Cochise County Assessor showing tax parcel no. 106-05-005 is
4 attached as Attachment B.

6 **IT IS ORDERED:**

7
8 1. Contested Case. This contested case shall be known as *In re Richard A. and Reva*
9 *Kirkman* and it will determine appropriable water rights asserted in the Statement of Claimant
10 and objections that were filed to Watershed File Report 112-20-BC-271 published in the Final
11 San Pedro River Watershed Hydrographic Survey Report (1991). Copies of objections can be
12 found under the case name and number on the following website:

16 2. Litigants. The litigants in this contested case are the Claimants, the current
17 landowner, all persons who filed objections to the WFR, and parties who are allowed to intervene
18 by order.

19
20 3. Court-Approved Mailing List.

21 A. The initial Court-approved mailing list for this case shall include all
22 persons listed on Attachment C to this order. The list may be modified
23 only by filing a motion with the Special Master to amend the Court-
24 approved mailing list. Litigants are responsible for using the current
25 Court-approved mailing list.

1 B. A copy of any pleading filed with the Clerk of the Maricopa County
2 Superior Court in this case shall be served upon each person listed on the
3 Court-approved mailing list.

4 C. Claimants wishing to be added or removed from the mailing list shall file
5 a motion with the Special Master. Parties allowed to intervene will be
6 automatically added to the Court-approved mailing list.


7
8 D. The Clerk of the Court will send copies of all minute entries and orders
9 issued in this case to the parties listed on the Court-approved mailing list.
10 Upon request, the Clerk of the Court will provide copies by email. Parties
11 may request emailed copies of minute entries and orders by completing
12 and submitting a CONSENT FOR ELECTRONIC RECEIPT OF WATER
13 CASE DOCUMENTS, which is attached as Attachment D.
14

15 4. Status Conference. An initial status conference shall be held to determine
16 whether the Claimant or current landowner, David E. Johnson, intend to pursue claims for rights to
17 appropriable water for irrigation or domestic use. If no person claiming a water right appears at
18 the Status Conference, then Statement of Claimant 39-6110 and this case will be dismissed and
19 no further action will be taken with respect to the WFR or the objections filed to the WFR.


21 The Status Conference shall be held on **April 7, 2022 at 2:30 p.m.** The Status

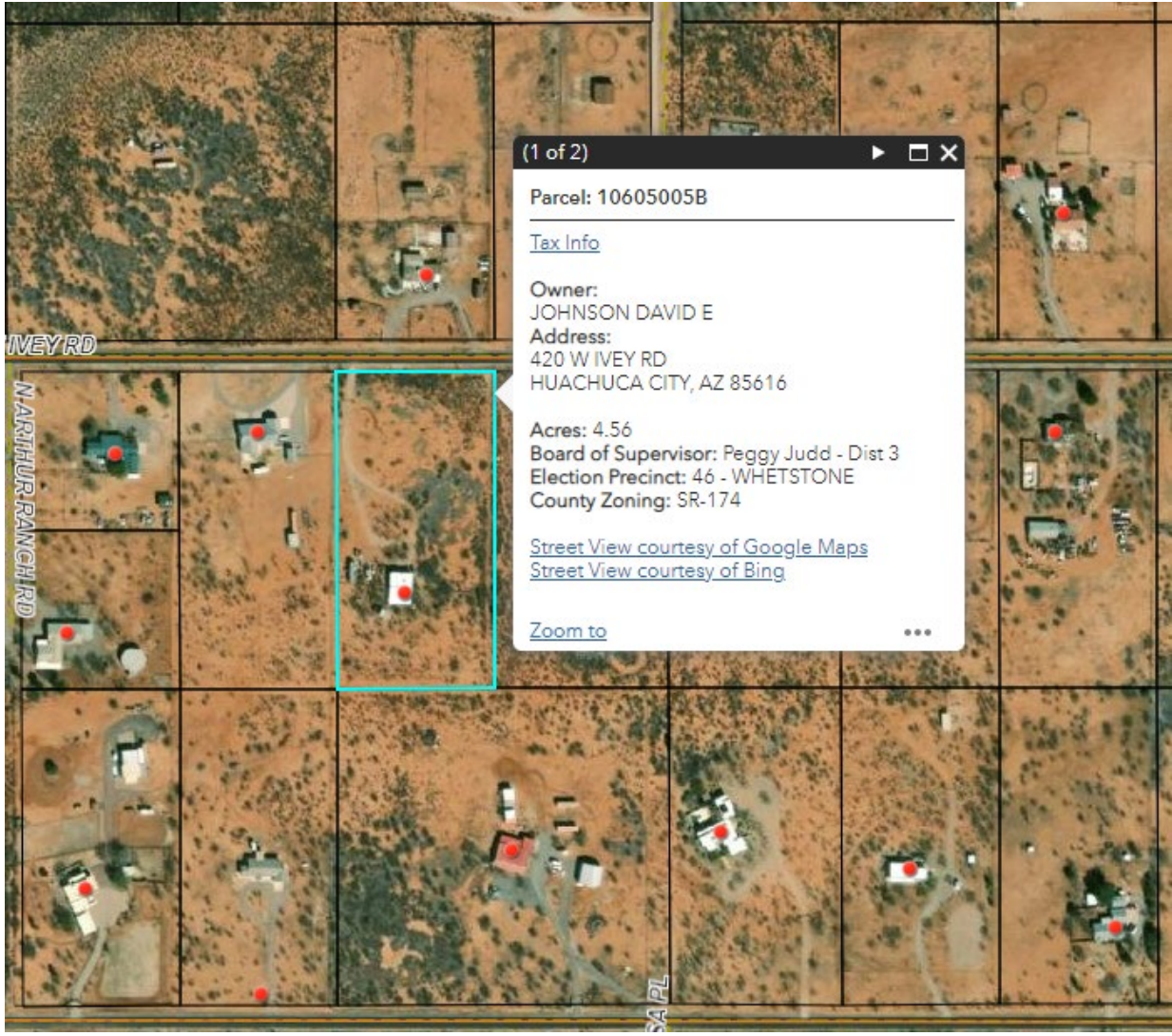
