Richard and Reva Kirkman, the claimants, are not present

David Johnson states that he intends to claim a right to water but has not yet filed a Statement of Claimant.

The Court explains the water rights adjudication process for appropriable water and how the location of wells that are used to pump water affects a claim for a water right. Mr. Johnson's well is in the San Pedro River watershed. The question is whether it is in the subflow zone.

The Court explains to Mr. Johnson the process of filing Statement of Claimant for a water right if he wants to proceed with making a claim.

For the reasons stated on the record,

IT IS ORDERED that if Mr. Johnson intends to assert water rights, he shall contact and work with ADWR regarding his claim and shall file a Statement of Claimant.

IT IS FURTHER ORDERED Mr. Johnson shall research his property using ADWR's interactive map to determine whether the well which will be the source of the water is located inside or outside of the subflow zone.

The Court may stay this case if Mr. Johnson files a Statement of Claimant and it is determined that his well is located outside the subflow zone for the San Pedro River watershed. The Court will set another virtual Status Conference once the pertinent information is gathered as stated on the record.

Mr. Foy states that Mr. Johnson's well number is: 55-559595.

The purpose of the Status Conference is for Mr. Johnson to inform the parties whether he has filed a Statement of Claimant and intends to proceed with seeking a claim

for a right to appropriable water. Mr. Johnson will also be prepared to provide the registration number for the well.

General Explanation to Self -Represented Litigants. In Arizona, people, governmental entities, and businesses can acquire rights to appropriable water. Appropriable water comes from places such as rivers, streams, water flowing under the surface that is part of a stream or river (subflow), definite underground channels, lakes, ponds, and springs. The other source of water is groundwater pumped from a well which is not considered appropriable water. People can also acquire rights to groundwater, but the procedures are different than the procedures that apply to appropriable water.

As demand grew over more than the past century for water in Arizona, with the potential for conflict, it became clear that it was necessary to examine all of the claims to rights to appropriable water to establish valid legal rights to water that could be protected and enforced.

The Arizona legislature put a procedure in place that requires the court to determine whether a person, who has filed a Statement of Claimant, has a legal right to appropriable water. The procedure is known as a general adjudication. The purpose of

the general adjudication is to examine claims for water rights and define those rights. Many western states use general adjudications to determine water rights. General adjudications in some areas of the United States have been completed and others are still in process.

In the San Pedro watershed, more than a hundred thousand claims have been made for water for uses such as domestic, irrigation, stock watering, mining, and stockponds. The court will determine water rights of those persons who have filed a Statement of Claimant. The failure to file a Statement of Claimant can result in the forfeiture of a right to use appropriable water, so it is important that a person seeking a water right file a Statement of Claimant, have a Statement of Claimant filed on his or her behalf, or obtain an assignment of an existing Statement of Claimant.

University of Arizona Law Clinic

The Natural Resource Use and Management Clinic ("Clinic") at the University of Arizona James E. Rogers College of Law is establishing a program to represent claimants in the General Stream Adjudication who need legal representation and meet certain criteria. Legal services, from case initiation through a settlement negotiation, will be provided by law students studying environmental and water law and will be overseen by a water law attorney. Legal services do not extend to representation at trial.
