On February 24, 2023, the United States filed a Fifth Report on State Law Claims within the San Pedro Riparian National Conservation Area (“Fifth Report”) in response to the January 18, 2023 Order from this Court. The Fifth Report was required to provide the status of several specific Statements of Claimants (“SOCs”) and any other corrections necessary to ensure the United States’ state-law claims for water rights in the San Pedro

1 Riparian National Conservation Area are accurately reflected. It should be noted that after
2 the filing of the Fifth Report, Contested Case W1-11-1344 was deconsolidated from this
3 Contested Case W1-11-232, therefore any SOC's to be dismissed that are associated with
4 Contested Case W1-11-1344 will be addressed in a separate Order from this Court.

5 Pursuant to the United States' Fifth Report filed February 24, 2023, and as
6 reflected in the schedule of proposed *de minimis* abstracts, which is attached as Attachment
7 A,

8 **IT IS ORDERED** that the following SOC's are reinstated as part of Contested Case

15 **IT IS FURTHER ORDERED** that, while SOC 39-6017 appears to have been
16 inadvertently omitted from any watershed file reports within the San Pedro hydrographic
17 survey area, the United States does not intend to pursue the claim therefore it is dismissed,
18 and no further action will be taken.
