This case involves one *de minimis* claim for a water right acknowledged in Watershed File Report 114-01-CCD-010 ("WFR") included in the final hydrographic survey report for the San Pedro Watershed ("San Pedro HSR") completed on November 20, 1991. On April 7,

2021, the Arizona Department of Water Resources ("ADWR") filed an amended WFR that analyzed the *de minimis* claim for the water right.

In 1994, the Special Master issued a Memorandum Decision, Findings of Fact, and Conclusions of Law for Group 1 Cases involving Stockwatering, Stockponds, and Domestic Uses, dated November 14, 1994, amended February 23, 1995, approved and modified September 27, 2002 ("Decision"). The Decision established the procedures for adjudicating *de minimis* water rights for claims in the San Pedro watershed. The Decision directs that after proposed water right abstracts have been prepared, "the litigants will be provided an opportunity to suggest the correction of mistakes in the proposed abstracts." Decision, p. 47. Once the clerical corrections have been completed, the abstract will be included in a catalog of proposed water rights where it will be subject to a very limited set of objections and, ultimately in a final decree. As required by the Decision, a proposed water right abstract has been prepared for the *de minimis* water right analyzed by Watershed File Report 114-01-CCD-010, which is attached as Appendix A.

IT IS ORDERED that any suggested corrections to the proposed abstract shall be filed on or before October 11, 2021.
