**IT IS FURTHER ORDERED** amending paragraph 9(B) of Pre-Trial Order No. 1 in its entirety to state as follows:

The DWR shall provide meeting space if requested, and technical and administrative support to the committee to the extent DWR has the necessary resources. The DWR shall have no voting power in the committee, nor shall the DWR assert any position regarding the recommended resolution of any issue raised within the committee, except as to how any proposed committee recommendation would affect its responsibilities and duties in this case.

The steering committee shall select a chair who shall serve for a term not to exceed two consecutive years. The chair shall act as moderator and reporter of the committee responsible for producing minutes and reports of the committee. All committee meetings shall be open to the parties and to the public. Participation in the meetings by persons other than committee members shall be at the discretion of the committee.

The chair shall prepare the notice of steering committee meetings. The DWR shall file the notice of each steering committee meeting with the Court and shall mail a copy of the notice to each member of the committee. Notice of the committee meetings shall be given to all parties in the same manner as notice must be given of other documents filed in this action pursuant to section 5 of Pre-Trial Order No. 1.
