The Court has considered argument of counsel and the materials submitted in support of and in opposition to Salt River Valley Water User's Association's and the Salt River Project Agricultural Improvement and Power District's (collectively "SRP") Motion for Summary Judgment against Henry M. Shill and Don H. Shill dba Shield Ranch, Inc. (collectively "Shield Ranch").
