The Court and Mr. McGinnis, Ms. Pelton, Mr. Staudenmaier, and Mr. Mabery discuss NBJ Ranch Ltd. Partnership's motion to dismiss or, in the alternative, stay Salt River Project's application for injunctive relief.

Discussion was held concerning the length of the evidentiary hearings and the need for additional hearing days. The parties agreed that the evidentiary hearings set on October 11, 2007, and December 13, 2007, should be continued until a time when three days of hearing are available so that both the NBJ Ranch Ltd. Partnership and the Kovacovich and Wiertzema matters can be heard.

IT IS ORDERED denying NBJ Ranch Ltd. Partnership's motions to dismiss or, in the alternative, to stay Salt River Project's application for injunctive relief.

IT IS FURTHER ORDERED, denying Kovacovich Inv., Ltd. Partnership's and Wiertzema Family Trusts' Notice of Joinder of Pending Motions to Dismiss or Stay in the Order to Show Cause; Motion for Request of a Status Conference and Motion to Designate Issues of Broad Legal Importance.

IT IS FURTHER ORDERED that declarations shall be submitted for direct examination of expert witnesses at the evidentiary hearing. Any expert witnesses shall still be available for cross examination and re-direct.

IT IS FURTHER ORDERED the parties shall confer and provide a stipulated time for the continued three (3) day hearing on or before **October 12**, **2007**.
