LET THE RECORD REFLECT that the Court notes that it would not be inclined to grant any further continuances unless a settlement is reached.

## As to the Status of Settlement Discussions on the Gila River Indian Community Water Rights Claims:

Rodney Lewis, representing the Gila River Indian Community (GRIC), reported that substantial progress has been made. He stated that the agreements between the cities and towns as well as the south-side pumpers are progressing. He also stated that problems still exist with the Upper Gila Valley, Franklin Irrigation District (FID) and the San Carlos Apache Tribe. He further stated that parties are still on track for Senator Kyl's deadline of 9-30-99 for having negotiations completed and the legislation drafted for Congress.

Robert Hoffman, representing Central Arizona Water Conservation District (CAWCD), stated that a drafted stipulation to settle the federal litigation has been negotiated by the parties and he was optimistic about its approval.

John Weldon, representing Salt River Project, stated that major differences of opinions still exist on settlement issues. He stated that numerous issues that were originally unresolved, remain unresolved. For example, he stated that it has not been determined how this settlement will be funded. He stated that federal budget negotiations will have to take place on the appropriation procedure.

claimants in this matter who are not already represented or who
are not presently on the court-approved mailing list. The Court
stated that it was determined the current ADWR mailing list is
40 percent inaccurate. The Court further stated that this is
not a viable solution in light of the approaching deadlines.

Mr. Anthony Fines, representing the Gila Valley Irrigation District (GVID), stated that he has submitted to ADWR the federal court-approved mailing list for Globe Equity as well as the GVID current member list.

Mr. David Brown, representing the Franklin Irrigation District (FID), stated that he would be providing a list of current members shortly.

Patrick Barry, representing the United States, stated that they are requesting this information in order to formulate the scope of their Motion for Summary Judgment, not necessarily to require that notice be given to all parties. He stated that they are interested in any claims the members of the district may have previously filed or are currently pending, other than Globe Equity 59 Decree claims.

Jan Ronald, representing ADWR, stated that formulating such a list as requested by Mr. Barry may be possible. Mr. Barry will meet with ADWR to acquire the claimant information.

Special Master John Thorson stated that he is working with ADWR and the Steering Committee to recommend how to resolve the mailing list issue. He stated that he will prepare a draft report on the mailing list issue within the next three weeks.
