IT IS FURTHER ORDERED directing the United States to provide ADWR access to the aerial photography, survey maps, and notes used by the Bureau of Land Management to prepare the August, 2009, GIS cover based on legal descriptions the United States previously disclosed.

Mr. Leininger stated it is not necessary to have a stay. The case has not been stayed only the preparation of ADWR's report. The United States will continue to research the documentation, and the legal determinations of law can proceed.

The Special Master stated two motions are pending on two legal issues being briefed, this case has not been stayed, and he intends to proceed with that briefing.

Discussion is held regarding the current mailing address of Stilde Investment, LLC.

IT IS ORDERED directing the United States to provide an updated list of the names and addresses of lessees, allottees, or permittees associated with the conservation area.

Further discussion is held regarding the Bureau of Land Management continuing to resolve the railroad right of way issue. The United States will submit to ADWR the information they obtain regarding the right of way.
