On April 29, 2009, the Court approved the course of action outlined in the reports of the Arizona Department of Water Resources ("ADWR") dated January 31, 2007, and October 15, 2008. In its October 15, 2008, report, ADWR proposed "to commence the summary adjudication process approved by the Court in 2002 for all existing *de minimis* uses that meet the *Sands* criteria for certain small domestic, stockpond and stockwatering uses." This work involves several activities.

The Special Master will meet with ADWR's staff to discuss the work directed by the Court. The Arizona Supreme Court has held that "A.R.S. § 45-256 expressly authorizes ex parte communications between a general adjudication judge ... and DWR." Although the Special Master may initiate ex parte communications with ADWR, the Court held that the ex parte communications approved by the Arizona Code of Judicial Conduct "generally require notice to the parties.... [N]otice is the rule rather than the exception."

Accordingly, the Special Master informs claimants and parties he will meet with ADWR's staff on January 26, 2010. The Special Master plans to discuss with staff the commencement and completion of the work the Court directed in this contested case. The meeting will not be recorded. Following the meeting, the Special Master will enter appropriate orders.
