**MINUTE ENTRY CORRECTION**

On October 15, 2003, Mr. Callahan requested the office of the Special Master to correct a statement reported in the minute entry issued on October 14, 2003. The Special Master has reviewed the tape of the telephonic conference. The following paragraph on page 4 of the October 14, 2003, minute entry is corrected to state as follows:

Mr. Callahan stated that any testimony that Mr. Philip C. Briggs may offer can only be presented on behalf of the individuals named in the statements of claimant shown in the declarations and not on behalf of the Verde Valley Water Users, Incorporated, which is not a claimant or party in the Gila River

Adjudication. The Yards and the Kovacoviches filed the listed statements of claimant. Mr. Callahan stated that the issue of the organization's participation in judicial proceedings related to this adjudication has previously been raised and ruled upon by the Court. Mr. Mabery stated that the Verde Valley Water Users, Incorporated had retained Mr. Briggs, and Mr. Mabery was aware of the issue Mr. Callahan was raising. Mr. Mabery stated that at this time he did not object to Mr. Briggs' testimony being offered on behalf of the persons who filed the statements of claimant listed in the filings of Mr. Briggs' declarations.

The Special Master wants to hear prior to the cross-examination of Mr. Briggs why the Verde Valley Water Users, Incorporated has listed statements of claimant filed by the Yards and the Kovacoviches on filings made by the organization in this proceeding.
