TELEPHONIC CONFERENCE

DESCRIPTIVE SUMMARY: The Special Master will hold a telephonic conference on October 10, 2003, to address any matters that will facilitate the orderly and efficient conduct of cross-examination of witnesses.

**ORDER**

On September 26, 2003, counsel who represent parties in this proceeding filed a Joint Submission of Proposed Schedule for Cross-Examination of Witnesses. Counsel suggested that the Special Master consider holding a prehearing conference, perhaps telephonically, "to address any final details and facilitate the orderly and efficient conduct of cross-examination."

A telephonic conference will be held on October 10, 2003. The proposed schedule allows time for the cross-examination and redirect testimony, if allowed, of the expert witnesses who submitted declarations and fills the two days set for the hearing. The Special Master will

accept the proposed schedule if no valid objection is presented before or during the telephonic conference. The conference will be audio recorded, and copies of the tape may be ordered from the office of the Special Master.

IT IS ORDERED:

1. A telephonic conference will be held on **Friday, October 10, 2003, at 10:00 a.m. (MST)**, to consider any matters that will facilitate the orderly and efficient conduct of cross-examination at the hearing set on October 21 and 22, 2003.

2. At 10:00 a.m., counsel should dial from the telephone they will personally use **(602) 542-9001**. This telephone number will be used to join the conference and reconnect if the connection is lost. If you are using a speaker telephone, dial from the speaker mode. Do not use the hold button, transfer key, or switch hook. Do not hang up if the telephone rings many times; you will be connected when someone else calls in.

3. Each participant will bear any long distance telephonic charges.
