ORDER GRANTING REQUEST TO CONTINUE BRIEFING SCHEDULE

CONTESTED CASE NAME: *In re Fort Huachuca*.

DESCRIPTIVE SUMMARY: The Special Master grants the request of the United States to continue the briefing schedule set in the July 19, 2006, order. The telephonic status conference previously set on January 18, 2007, is not changed.

DATE OF FILING: September 26, 2006.

The United States has requested that the briefing schedule of the designated issues be continued for four months. The additional time will allow the United States to confer with the other parties in this case about the possibility of a more comprehensive settlement of water right claims of the United States in the San Pedro River Watershed.

At a status conference held on September 19, 2006, in a matter involving the San Pedro Riparian National Conservation Area, the Special Master heard the desire of several parties to explore the possibility of a comprehensive settlement involving other water right claims of the United States. Continuing this briefing schedule was believed to

be conducive to these exploratory discussions in which the United States will take the facilitating lead.

Because the deadline for filing motions is immediate and for the reasons stated in the prior orders granting extensions of the briefing schedule, the Special Master will rule on the motion without waiting for esponses and will grant the request. These new deadlines will not be continued absent very extraordinary circumstances.

IT IS ORDERED:

- 1. The request of the United States to continue the briefing schedule is granted. Section 8 of the May 5, 2005, Scheduling Order is revised to extend the deadline for filing motions concerning the designated issues to **January 25, 2007**.
- 2. Section 9 of the Scheduling Order is revised to extend the deadline for filing responses to **March 26, 2007**.
- 3. Section 10 of the Scheduling Order is revised to extend the deadline for filing replies to May 29, 2007.
 - 4. This schedule will not be extended absent very extraordinary circumstances.
- 5. The telephonic status conference set on **Thursday**, **January 18**, **2007**, **at 10:00 a.m.** (**MST**) is not affected by this order. The United States and other parties shall report on the progress of settlement discussions. The call-in telephone number for the conference will be provided at a later time.
