NOTICE AND ORDER

CONTESTED CASE NAME: *In re PWR 107 Claims.*

HSR INVOLVED: San Pedro River Watershed Hydrographic Survey Report.

DESCRIPTIVE SUMMARY: The Special Master provides notice of his office's new addresses and revises the schedule for entering a partial decree.

The Special Master's office has moved to the Maricopa County Superior Court, Central Court Building, Suite 5B, 201 West Jefferson, Phoenix, Arizona 85003-2205. The new telephone is (602) 372-4115 and facsimile is (602) 372-8733.

The United States and the San Carlos Apache Tribe were not able to resolve a disputed issue in time to comply with the schedule set forth in the July 19, 2006, order. On January 12, 2007, these parties advised that they had resolved all issues between them regarding the fourteen claims of the United States remaining to be determined in this case.

At the telephonic conference held on January 18, 2007, these parties confirmed the resolution and indicated that the stipulated abstracts of water rights could be submitted to the Arizona Department of Water Resources ("ADWR") by January 26, 2007. The Special Master informed the parties that a revised schedule with the same time periods set forth in the July 19, 2006, order would be issued. That prior order remains in effect in all other respects and directives.

IT IS ORDERED:

1. On or before **January 26, 2007**, the United States and the Tribe shall execute the stipulated abstracts of water rights for the fourteen springs described in the July 19, 2006, order, and the United States shall submit to ADWR the complete proposed stipulation and abstracts of water rights.

2. On or before **March 27, 2007**, ADWR shall review the proposed stipulation and abstracts in accordance with the directives set forth in the July 19, 2006, order and file its recommendations.

3. On or before **May 11, 2007**, any party in this case may file objections or comments to ADWR's recommendations.

4. On or before **May 11, 2007**, the United States shall file the withdrawal of the statements of claimant it has stated will be withdrawn.

5. On or before **July 10, 2007**, the Special Master will rule on objections or comments and file a report and proposed partial decree with the Court.

6. Claimants shall have sixty days to file objections to the Special Master's report and proposed partial decree. The last day to file objections will be set forth in the Special Master's report.
