For good cause shown, **IT IS ORDERED:**

1. The Arizona State Land Department shall disclose on or before August 1, 2016, the name of its expert on land valuation, the expert's curriculum vitae, and no less than five dates between and including September 6, 2016, and October 30, 2016, that the expert will be available for purposes of a deposition.
2. The deadline for filing a notice of deposition for the Arizona State Land Department's expert on land valuation shall be extended to September 6, 2016.
3. The Arizona State Land Department shall file and serve the report of its expert on land valuation on or before August 15, 2016.
4. The Arizona State Land Department shall file by August 15, 2016, a fourth Supplemental Disclosure Statement that provides the information regarding its expert on land valuation.
