DESCRIPTIVE SUMMARY: The Special Master sets dates for filing deposition notices and supplements to Disclosure Statements

DATE OF FILING: December 2, 2015.

At the request of the parties, the Court extended the discovery deadline in this matter to April 15, 2016, to allow the parties additional time to complete discovery. The parties represented that they needed additional time to conduct depositions of currently known individuals due to scheduling difficulties and the locations of such individuals.

Discovery has been ongoing during the three years since the filing of the initial Disclosure Statements in the Second Phase of this contested case. To date, ten individuals have been identified in the initial and supplemental Disclosure Statements as either potential witnesses or persons having relevant knowledge or information. Given that discovery must be completed in approximately four months, it is appropriate that the parties shall file supplemental Disclosure Statements with respect to potential witnesses, persons with knowledge, persons who have given statements and experts. The

supplemental filings shall provide information which was either not provided or is a change to the information provided in either an initial or a supplemental Disclosure Statement. The supplemental filings shall not duplicate information included in the initial or supplemental Disclosure Statements filed to date.

## IT IS ORDERED:

- 1. On or before January 15, 2016, the parties shall file their respective notices of deposition for the currently known individuals. Amended and additional notices of deposition may be filed after January 15, 2016, and before the discovery deadline when necessary to address scheduling changes.
- 2. On or before March 7, 2016, each party shall file a supplement to its respective Disclosure Statement which shall:
  - a. List the names, addresses and telephone numbers of any witnesses whom the disclosing party expects to call with a fair description of the substance of each witness' expected testimony.
  - b. List the names and addresses of all persons whom the disclosing party believes may have knowledge or information relevant to the events, transactions or occurrences that gave rise to each claim and the nature of the knowledge or information each such individual is believed to possess.
  - c. List the names and addresses of all persons who have given statements, whether written or recorded, signed or unsigned, and the custodian of the copies of those statements.
  - d. List the name and address of each person whom the disclosing party expects to call as an expert witness, the subject matter on which the expert is expected to testify, the substance of the facts and opinions on which the expert is expected to testify, a summary of the grounds for each opinion, the qualification of the witness and the name and address of the custodian of copies of any reports prepared by the expert.
