23 IT IS FURTHER ORDERED as follows:

- 24 1. Pascua Yaqui file its response to the jurisdictional issue on or before March 15,  
25 2007.
- 26 2. All objectors other than Pascua Yaqui file their responses to the Settling Parties'  
27 Motions for Summary Disposition on or before March 15, 2007.
- 28 3. The Settling Parties file their replies to Pascua Yaqui's March 15 jurisdictional

claim and to all other objections on or before March 30, 2007.

4. The Court set a hearing on all fully briefed matters on the 27 day of April, 2007 at 10:00 a.m.
5. Pascua Yaqui files its response to the remaining issues in the Settling Parties Motion for Summary Disposition on March 30, 2007.
6. The Settling Parties file their replies to the memorandum filed by Pascua Yaqui on April 16, 2007.
7. The Court schedule a hearing on the remaining Pascua Yaqui issues on the 27 day of April, 2007 at 2:00 p.m.
8. All pleadings and memoranda will be served by normal procedures, facsimile, email or hand-delivery except that service on objectors and settling parties shall be by same day service.
