The Court notes that with the exception of the Pascua Yaqui Tribe ("the Tribe") and Mr. Marshall Marinakis none of the claimants who have filed objections to the proposed water rights settlement agreement are in attendance.

The Court informs Ms. Diana McNair, who is not a licensed attorney, that she cannot act as legal counsel for Mr. Marinakis in this matter. Mr. Marinakis will have to appear personally or by legal counsel.

The Court, Mr. Sparks, and Mr. Barry discuss the representation of the Pascua Yaqui Tribe in this special proceeding. The Tribe has not filed a statement of claimant in the Gila River Adjudication, but the United States filed a claim on behalf of the Tribe.

Mr. Sparks states that the Tribe wants to present evidence showing how the proposed settlement would affect the Tribe's water rights. He states that the Tribe has not filed a statement of claimant but has been compiling information to file a claim at a future time.

The Court and Mr. Sparks discuss the language of the settlement agreement that states that the agreement shall not be construed to quantify or otherwise affect the water rights, claims, or entitlements to water for any Indian tribe, band, or community other than the Tohono O'odham nation.

Mr. Barry states that he is participating as the Secretary of the Interior's lawyer acting pursuant to the Congressional Act of this proposed settlement.

Mr. Dworkin reminds the Court of the December 31, 2007, deadline for a final non-appealable court order regarding this water rights settlement.
