1ST PREFERENCE- NEW JERSEY OWNED AND SIRE
2ND PREFERENCE- NEW JERSEY OWNED OR SIRE (MUST BE FULLY OWNED.
(TRANSFERS WITHIN THE LAST 30 DAYS WILL BE DEALT WITH ON A CASE-BY-CASE BASIS)
3RD PREFERENCE- HORSES WHO HAVE MADE 2 OF THEIR LAST 3 STARTS IN NEW JERSEY .
(QUALIFIERS IN NEW JERSEY WILL BE INCLUSIVE OF THIS SYSTEM, QUALIFIERS FROM OTHER TRACKS WILL NOT COUNT AGAINST YOU).
4TH PREFERENCE- DATE/BACK DATE
