Infectious Disease Updates for EMS Clinicians

AS EMERGENCY MEDICAL SERVICES continue to transport patients with COVID-19 illness as well as immunosuppressed patients, both patients and EMS clinicians should continue to wear surgical masks on all calls for service. For patients with respiratory symptoms, or suspected/proven COVID-19 illness, EMS clinicians should remember to use appropriate personal protective equipment (PPE), including: gloves, gown, eye protection, and a fit-tested N-95 respirator. MIEMSS will continue to post COVID-19 EMS Guidance documents online at <https://www.miemss.org/home/infectious-diseases> as updates occur.

■ **Monkeypox.** Monkeypox is a viral illness that typically starts with flu-like symptoms and progresses to a rash, characterized by fluid-filled lesions that resemble chickenpox or herpes, within three days. The rash typically starts on the face and spreads to other parts of the body. Viral spread typically requires close

contact with an infected person or animal (e.g., primates, small mammals), contaminated materials, or by respiratory droplets that can travel as far as six feet.

EMS clinicians should pay close attention to recommended personal protective equipment (PPE), which includes: gown, gloves, eye protection

EMS Transfer of Care Times

MIEMSS continues to closely monitor times on the transfer of care from EMS to hospital staff, and sends weekly reports to 34 Maryland hospitals and freestanding emergency departments. All of the Region III hospitals and many in Region IV and V receive these reports. Several hospitals have used these data to re-evaluate triage processes and focus their attention on improving transfer of

care times.

We encourage leaders to continue collaborative discussions with hospitals on strategies to transfer care from EMS to hospital staff in an efficient fashion. In addition, the Direct to Triage Protocol enables delivery of stable patients to the ED triage waiting area. Of note, it is important that the patient report be conveyed to nursing staff when using this protocol. ■

■ **Talbot EMS Introduces Ultrasound on County Ambulances** (*The Star Democrat*). Talbot County Emergency Services, Emergency Medical Services Division, has a new tool in its toolbox – an ultrasound machine on each of the ambulances in its fleet. Talbot EMS approached the Talbot Paramedic Foundation about supporting this new and exciting pilot project for the state of Maryland, and they agreed. ■ **New Maryland Fire & EMS Department Ready to Begin Hiring Career Personnel** (*Carroll County Times via JEMS*). Carroll County's Fire and Emergency Medical Services Department, which was officially established two years ago this month, is now ready to start hiring new career personnel, according to Director Michael Robinson Sr. "Over the past year, the [department] has made significant progress to create infrastructure, policies and

procedures and is now poised to begin hiring personnel, incrementally, who will deploy to fire stations in the next several months," Robinson said in a staff report he presented to the Board of Carroll County Commissioners on October 6. Read more here: <https://bit.ly/3TBLEFa>.

■ **Marylanders 5 and Older Now Eligible for Bivalent COVID-19 Boosters So Maryland Families Can Stay COVIDReady** (*Maryland Department of Health*). The Maryland Department of Health (MDH) has announced that Marylanders 5 years old and older are now eligible to receive the updated COVID-19 bivalent booster shot, further expanding the state's COVIDReady campaign to encourage Marylanders to maximize their protection against COVID-19 this fall and winter. "Marylanders 5 to 11 years old who have gotten their last COVID-19 primary vaccine or any recommended booster shot at least two months ago are now eligible for the updated COVID-19 bivalent booster shot," said MDH Secretary

Dennis R. Schrader. "We urge all Marylanders 5 years old and older to get the bivalent booster shot as soon as they can to be COVIDReady and together safely enjoy the colder months and upcoming holidays." Read more here: <https://bit.ly/3Tx2t4f>.

■ **Protecting EMS Responders from Violence** (*US Fire Administration*). Violence is the second most frequent cause of nonfatal injuries to emergency medical services (EMS) clinicians, according to 2020 data from National Institute for Occupational Safety and Health (NIOSH) data tracking. Most of these injuries are caused by the patients EMS clinicians are treating. An EMS department in Austin, Texas, is implementing a training program that focuses on changing how violent patients are approached, including how to detect a possibly violent patient early in the incident. 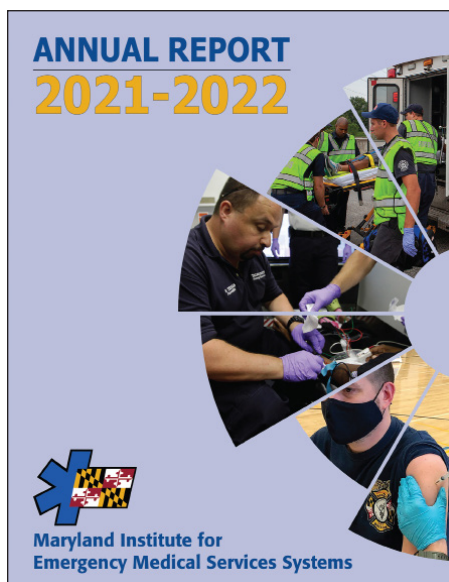
Over the past year, MIEMSS has also sought to expand access to education in new ways. For example, through support from a federal grant, the agency instituted an education stipend in FY 2022 to help

The Maryland Resuscitation Academy (RA) is pleased to announce the dates of our Fall 2022 two-day Academy. This course is being offered Tuesday and Wednesday November 29 & 30, 2022 at Howard County's James N. Robey Public Safety Training Center in Marriottsville, MD. The Maryland RA is a two-day, intensive course dedicated to improving survival rates of patients suffering out of hospital cardiac arrest, and is suitable for Medical Directors, Fire/EMS Chiefs, EMS supervisors, EMS personnel of all levels, and hospital staffs across the state of Maryland and surrounding states and regions. Based on the curriculum of the world-renowned Resuscitation Academy in Seattle WA, the Maryland RA is co-sponsored by the Howard County Department of Fire and Rescue Services (HCDFRS), The Maryland Institute of Emergency Medical Services Systems (MIEMSS), and the Heart Rescue Project.

Through your attendance, you will increase your understanding of the interventions important to pre-hospital cardiac arrest survival and learn to implement ways to improve survival rates in your own community. The academy features acclaimed faculty who are accomplished in the field of cardiac arrest survival, with a focus on the science of CPR, the importance of time, the importance of measuring performance, the critical role of dispatch, pediatric cardiac arrest, and more. Additionally, the academy includes an extensive, in-depth, practical train-the-trainer session where all class participants will learn and become confident in delivering High Performance CPR. Each participant will also leave with a standardized curriculum (including instructor guide and standardized videos) to begin to teach this practice in your department.

The Academy is held both days from 8:30am–5:00pm and includes a continental breakfast and working lunch. Tuition is complimentary, and generously covered by Academy sponsors. Additional details will be provided following acceptance into the academy.

MARYLAND STARS OF LIFE AWARDS

Each year, the Maryland Institute for Emergency Medical Services Systems (MIEMSS) celebrates EMS Week by honoring men and women across Maryland who have contributed to the EMS system. MARYLAND STAR OF LIFE AWARD

This award may be given to an individual, multiple individuals, or teams on the same incident for an outstanding rescue under extreme circumstances by EMS personnel.

MARYLAND EMS CITIZEN AWARD

This award is intended for citizen rescuers who have demonstrated quick thinking, fast action, and heroism.

EMS CLINICIAN OF THE YEAR

This award recognizes a clinician who has made outstanding contributions in the past year to the continuous improvement of emergency medical services in Maryland (for example, in the areas of quality assurance, public or EMS education, prevention, delivery of EMS services, and new technology).

EMD CLINICIAN OF THE YEAR

This award is given for extraordinary efforts in assisting the public through dispatch in this vital portion of the Chain of Survival.

OUTSTANDING EMS PROGRAM

This award recognizes a program that offers an innovative approach to reducing death and disability. The program must be affiliated with an EMS system component, such as a hospital, educational facility, rescue squad, or EMS organization.

LEON W. HAYES AWARD FOR LIFETIME EXCELLENCE IN EMS

This award is given to an individual who has devoted a lifetime of dedication to excellence in patient care, compassion and respect for each patient, and commitment to continuous improvement of the Maryland EMS system through his/her professional and personal life.

MARYLAND EMS-CHILDREN (EMS-C) AWARD

This award is given to an adult or program that has demonstrated ongoing dedication and commitment to improving the care for children and for promoting Family Centered Care in a Maryland EMS program or hospital.

MARYLAND EMS-GERIATRIC (EMS-G) AWARD

This award is given to an individual or program that has demonstrated ongoing dedication and commitment to improving the EMS care of the elderly in Maryland.

The Maryland EMS for Children program is in search of children and youth in Maryland who have demonstrated steps to take in an emergency or ways to be better prepared for an emergency. We will be recognizing children and youth who acted so that others would receive “The Right Care When It Counts.” Each nominee will receive a patch and certificate and be eligible for a state award at a ceremony during EMS Week 2023.

Children and youth who have met one or more of the following criteria are eligible for Right Care Awards:

1. Activates the Emergency Response System by calling 9-1-1 in an emergency
2. Calls the Poison Control Center in an emergency (1-800-222-1222)
3. Provides family emergency phone numbers, address, and contacts to emergency responders
4. Knows and practices an emergency plan at home
5. Applies knowledge learned in a first aid class
6. Performs CPR and/or uses an AED effectively
7. Knows his or her medical history (allergies, medications, special needs, etc.) and shares this information with emergency care providers
8. Participates in fire and injury prevention education in the community
9. Prepares, with his or her family, to respond to a disaster
10. Provides emergency assistance in the community

EMS Compliance Update

THE EMS BOARD is authorized to take disciplinary action against clinicians who engage in prohibited conduct to safeguard the integrity of the EMS system. COMAR 30.02.04.01 lists conduct which is prohibited. Below is a sample of actions the EMS Board has taken since April 2022, as a result of prohibited conduct. ■ **IRC21-063** (EMT) *May 11, 2022*. On March 6, 2019, the EMT pled guilty to the crime of theft scheme \$1,500 to under \$25,000. The EMT was subsequently sentenced on June 5, 2019, to a one-year jail term, with all but six days suspended. The EMT was also issued unsupervised probation for a period of one month. Furthermore, upon subsequent application for EMT certification renewal on October 23, 2021, the EMT failed to disclose the aforementioned disposition. As a result of the above findings, the EMT was reprimanded and placed on probation for six years.

■ **IRC22-001** (EMT) *May 11, 2022*. On December 22, 2021, the EMT was found guilty of second-degree assault. The EMT was subsequently sentenced to three months in jail with the entire sentence suspended, as well as three years of supervised probation. The EMT was

also ordered to attend mental health counseling. As a result of the above findings, the EMT was placed on probation concurrent with his criminal probation.

■ **IRC22-006** (EMT) *June 21, 2022*. On December 16, 2021, the EMT was found guilty of imperson-

ating a police officer, and was issued unsupervised probation before judgment for a period of one year, and assigned 200 hours of community service, to be completed by December 17, 2022. The EMT's certification is currently on probation for the EMT's first certification cycle (04/13/21 – 06/30/24) related to incident #: IRC21-002, pursuant to a Disposition Agreement entered into by the EMS Board on May 21, 2021, as a result of a second-degree assault conviction on October 18, 2019. As a result of the above findings, the EMT's certification is suspended for

90 days from the date of this notice, during which time the EMT must obtain a psychological evaluation for fitness for duty and complete an anger management program approved by the EMS Board. The EMT will also remain on probation until June 30, 2025.

■ **IRC22-002** (Paramedic) *August 17, 2022*. On January 6, 2022, a discrepancy in narcotics reporting was discovered, resulting from the Paramedic's failure to complete an electronic patient care report in a timely manner, as required by COMAR. As a result of this, as well as multiple previous incidents of failure to properly complete ePCRs, the jurisdiction temporarily suspended the Paramedic for a period of seven days, and issued a formal letter of reprimand. As a result of the above findings, the Paramedic's license is suspended for 30 days retroactively, with a 100% quality assurance review to be conducted within a period of 90 days. Additionally, the Paramedic shall meet with State EMS Medical Director Dr. Timothy Chizmar to discuss the matter, and will remain on probation for two years.

■ **IRC22-010** (EMT) *August 17, 2022*. On September 10, 2019, the EMT pled guilty to the crime of second-degree assault, and was issued supervised probation before judgment for a period of one year. The EMT failed to disclose the aforementioned disposition on his application for provisional EMT reinstatement. As a result of the above findings, the EMT was reprimanded

Maryland aims to reduce the number of crashes, and the resulting deaths and injuries, to zero by 2030.

Keep Kids Safe this Halloween

Halloween is rapidly approaching. Many young Ghouls, Ninjas, Princesses, Witches, and Superheroes will be on the streets and sidewalks across Maryland looking for tasty treats. To ensure the safety of young trick-or-treaters this Halloween, please remember the following tips:

- Utilize extra caution when driving, especially in neighborhoods. Excited children can be unpredictable and may not be looking for vehicles.
- If you are attending a Halloween celebration that includes alcohol, ensure that you plan a sober ride home.
- Speak with children before heading out. Remind them that even on Halloween, safety rules *still* apply. They must watch for vehicles and look both ways before crossing the street.
- Encourage the use of face paint or makeup to accent a child's costume instead of a mask. Masks can restrict vision and make it more difficult for a child to spot potential dangers.
- If your child's costume is not already bright, consider the use of reflective tape on their costume or bag, small lights, or other items to make children more visible as they trick-or-treat.

Expanding Maryland's Move Over Law

Originally passed in 2010, Maryland's Move Over Law required that drivers move over or slow down for emergency responders, law enforcement personnel, and CHART trucks who provide roadside assistance. In 2014, the law expanded to include tow truck drivers.

On October 1, 2022, the law expanded once again to include **all** vehicles while they are stopped, standing, or parked while displaying warning signals – including hazard lights, road flares, or other caution signals. If it is not safe or feasible to move over, motorists must slow down to a reasonable and prudent speed that is safe for existing weather, road, and vehicular or pedestrian traffic conditions.



Violation of Maryland's Move Over Law is a misdemeanor carrying a \$110 fine and one point on your license. If the violation causes a crash, the fine is \$150 and three points. If there is a death or serious injury, the fine is \$750 and three points.

for failure to disclose and placed on probation for one year.

■ **IRC22-018** (Paramedic) *August 17, 2022*. On March 7, 2022, the Paramedic pled guilty to the crime of DUI: Gen Imp/Inc of Driving Safely – 2nd off. The Paramedic was sentenced to six months of probation, 15 days of house arrest, and two months of intensive supervision. The Paramedic was also ordered to complete an alcohol highway safety class, an ignition interlock program, a drug and alcohol evaluation and treatment program, and a CRN evaluation program. As a result of the above findings, the Paramedic was placed on probation through the rest of her certification cycle, with random alcohol/drug testing at her expense.

■ **IRC22-023** (EMT) *September 19, 2022*. On September 24, 2021, the EMT was found guilty and sentenced to two years in jail, with all suspended, and two years of supervised probation for the crimes of Second Degree Assault and Carrying a Loaded Handgun on a Person. The EMT was also ordered to continue psychiatric therapy and attend an abuse intervention program. As a result of the above findings, the EMT was retroactively suspended for the 90-day period spanning from September 1, 2019, through November 30, 2021, and placed on probation through the EMT's next certification cycle, ending June 30, 2024. Additionally, a letter of reprimand was also issued to the EMT.

■ **IRC22-030** (EMT) *September 19, 2022*. On April 1, 2022, the

EMT was found guilty of second-degree assault. The EMT was subsequently sentenced to 10 years in jail with the entire sentence suspended, as well as three years of supervised probation. The EMT was also ordered to attend and complete domestic violence counseling. As a result of the above findings, the EMT was reprimanded and placed on probation concurrent with the EMT's criminal probation.

■ **IRC22-026** (EMT) *September 19, 2022*. On April 11, 2022, the EMT pled guilty to the crime of Distribution of Intimate/Sex Image, and was sentenced to supervised probation before judgment for a period of one year. As a result of the above findings, the EMT was reprimanded and placed on probation for one year from the date of this Final Decision. ■
