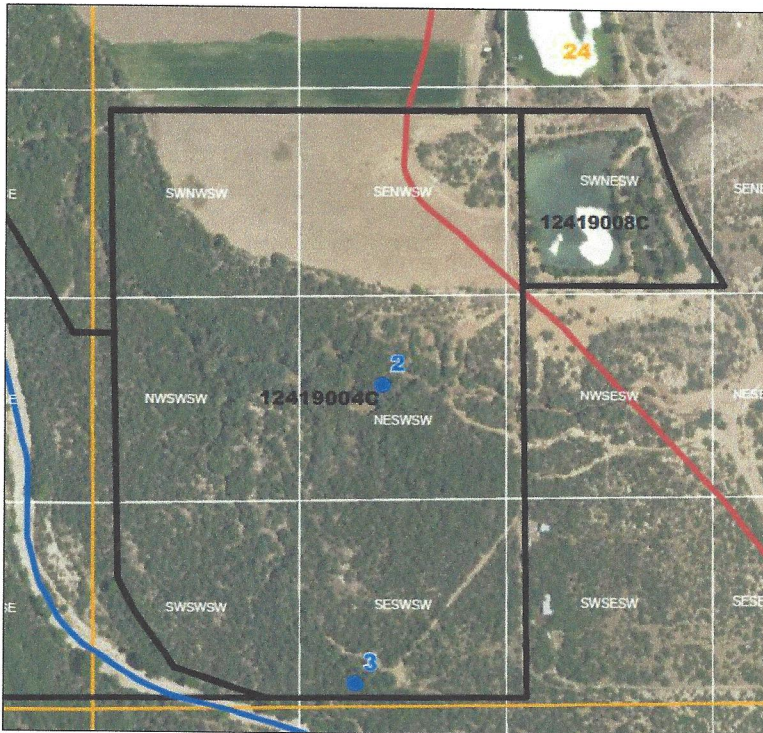
ORDER TO CONSOLIDATE CLAIMS
FOR WATER RIGHTS

DESCRIPTIVE SUMMARY: Order to consolidate claims for water rights associated with land owned by Jacob and Jennifer Kartchner located in Section 24 T17S R20E with *In re St. David Irrigation District*, contested case no. W1-11-1675.

This case involves potential water rights for irrigation uses, a primary storage reservoir and small reservoirs for use in sections 23 and 24 of T17S R20E that are the subject of watershed file report 112-14-BDA-007. This case was originally consolidated with and made a part of contested

1 case *In re Pomerene Water Users*, contested case no. W1-11-1676. On August 31, 2018, the
2 Pomerene Water Users Association filed a Notice of Termination stating that St. David Irrigation
3 District has claimed the Pomerene diversion structure and the Pomerene canal. The Notice of
4 Termination stated that Jacob and Jennifer Kartchner filed a petition to be annexed into the St.
5 David Irrigation District, which had been granted. Thus, the water rights asserted by Jacob and
6 Jennifer Kartchner that are the subject of watershed file report 112-14-BDA-007 should be
7 determined in *In re St. David Irrigation District*, contested case no. W1-11-1675.

8 According to the Cochise County Assessor's Office, the property encompassed by
9 watershed file report 112-14-BDA-007, located west of the Pomerene Canal and owned by Jacob
10 and Jennifer Kartchner includes the following tax parcels: 12419004C, 124-19-005F, 12419005J,
11 and 124-19-008C. Arizona


