Upon inquiry from Mr. Sparks, Mr. Dawson confirms that Daniel Stadtler is the Trustee of the Stadtler Trust.

The Court designates the case as a Track 1 case and directs ADWR to schedule a meeting with Mr. Stadtler, Mr. Dawson and the objectors to determine whether objections can be resolved.

Mr. Brown reports that other claimants may apply to join the St. David Irrigation District case and he will file a notice if and when additional claimants apply to join and St. David Irrigation District accepts those petitions.

IT IS ORDERED that ADWR shall schedule and hold a meeting pursuant to Rules for Proceedings Before the Special Master §8.02[1] on or before February 28, 2019, to resolve objections to water use on land owned by Mr. Stadtler individually or in trust involved in this contested case as well as contested cases W1-11-1910 and W1-11-1912. The meeting shall also include the parties involved in cases W-11-1917.

To facilitate discussions at the meeting, all parties are directed to bring to the meeting any deeds, aerial photographs, wells logs and other documents that are readily available to the party and relevant to the ownership of the land and past and present irrigation on the land.
