ORDER TO SET STATUS CONFERENCE

DESCRIPTIVE SUMMARY: Status conference set to determine proceedings necessary to address potential water rights for irrigation use.

This contested case involves a potential water right for an irrigation use in section 34 T16S R20E and section 3 T17S R20E identified by the Arizona Department of Water Resources

1 in Watershed File Report No. 112-17-BAD-001 (WFR). The WFR specifically identified the
2 irrigation use as 112-17-BAD-001-IR001.

3 Eldon J. Barney filed Statements of Claimant 39-5938, 39-12574, and 39-12575
4 (collectively the "Barney SOCs"). Joseph Marco and the Marco Family Partnership now own
5 land in section 34 T16S R20E and section 3 T17S R20E and have filed Statement of Claimant
6 39-18015 ("Marco SOC") to assert water rights included in the Barney SOCs. In the Marco SOC
7 a claim is made for water from a well, Well Registration No. 631735, for irrigation, domestic, and
8 stock watering uses. The Marco SOC states that the water right will be used on 100 acres of land
9 in section 3 T17S R20E with a maximum flow rate of 1,000 gallons per minute. The potential
10 water right for 112-17-BAD-001-IR001 lists the irrigated area as 186.5 acres with a maximum
11 observed estimated volume of 1063.1 acre-feet per year.

13 A status conference will be held in this case for the purpose of determining whether the
14 objections filed to potential water right 112-17-BAD-001-IR001 can be resolved by settlement or
15 whether a schedule for pre-trial discovery and motions should be set along with a trial date.
