ORDER VACATING TELEPHONIC
SCHEDULING CONFERENCE
AND STAYING THE CASE

1 This case involves potential water rights for irrigation and domestic use identified in
2 watershed file report 112-17-BDA-007 published in the Final San Pedro River Watershed
3 Hydrographic Survey Report (1991). The parties entered into a Partial Stipulation, Withdrawal
4 of Objections, and Request that the Special Master Approve Proposed Water Right Abstracts for
5 El Dorado Benson LLC ("Partial Stipulation") and submitted proposed abstracts for water rights
6 for El Dorado Benson LLC that were approved by Order dated August 4, 2020. The Partial
7 Stipulation also stated that El Dorado Benson LLC asserted a claim for a right to appropriable
8 water from a well identified as "W10" in the watershed file report. Arizona Department of Water
9 Resources has determined that the well is located outside the subflow zone. Accordingly,

10 IT IS ORDERED vacating the Telephonic Scheduling Conference set for August 10,
11 2019.

12 IT IS FURTHER ORDERED that the case is stayed with respect to the claim made in
13 Statement of Claimant 39-15930 for appropriable water from a well located outside the subflow
14 zone until completion of cone of depression and subflow depletion tests for that well.
