Mr. Cooper confirms with the Court that an agreement has not yet been reached.

He requests that in setting a schedule that consideration be given to his limited ability to access public records due to COVID restrictions.

It appears that the issue of doctrine of great and growing cities will be raised in this matter. Mr. Cooper states that he intends to focus more on historical use of the water.

Counsel agree that some discovery and a development of facts will be required in this matter.

The Court notes that Mr. Sparks filed a notice of filing a disclosure statement rather than actual disclosure statement. The Court will require a Case Information Report, required by Rules for Proceedings Before the Special Master, from counsel in the future in lieu of a disclosure statement.

Mr. Sparks explained that he had produced a substantial and comprehensive disclosure of documents that were evidentiary in nature and could not be appropriately provided to the Court at this time.

For the reasons stated on the record the Court sets the following deadlines:

Discovery deadline: March 15, 2021;
Dispositive motions due: May 3, 2021;
Trial: August 2, 2021

If desired, counsel may file a request with the Court to schedule a pre-trial conference.
