IT IS ORDERED that Thomas Benavidez on behalf of the Town of Huachuca City shall be added to the court-approved mailing list for this contested case W1-11-0245.

Mr. Brown states that his client does not believe that the two of the wells described in the Court's Order of June 12, 2019 are located on property owned by Babacomari Ranch Co. LLLP. He further states that the Town should identify the locations of the wells and the ownership.

The Court inquires of Mr. Benavidez if he can explain the ownership of the land on which wells two and three are located.

Mr. Benevidez states that he is not prepared to do so at this time because he just received notice of these proceedings last week and the Town needs to hire water counsel. Mr. Benevidez is general counsel for the Town. The Town has no objections to entering into settlement discussions with the objectors.

Mr. Brown reiterates that the Town should provide the location and ownership of the wells before the parties enter into settlement discussions.

IT IS ORDERED directing the Town of Huachuca City to hire water counsel and to submit a status report by **October 15, 2019.** The status report will advise the Court regarding the outcome of the meetings between the parties, status of the claims, and ownership of the land on which the Town's wells are located.
