Pima County Flood Control District (“District”) filed a motion to amend the abstract for proposed stock watering right 113-12-021-SW002 (Abstract). Subsequently, Arizona Department of Water Resources (ADWR) conducted an investigation of the place of use and

1 point of diversion for the claimed stock watering use and submitted a Report dated October 2,
2 2019 along with the map of the site of the place of use/point of diversion. The proposed
3 abstract attached as Attachment A has been revised to be consistent with the information
4 provided by ADWR. To ensure that the Abstract has been appropriately corrected, the Abstract
5 is being distributed to all parties before it is added to the Partial Catalog of Water Rights created
