
On July 15, 2019, the parties submitted a joint settlement report which resolved all
objections to proposed water rights claimed by Pima County except those potential water rights

1 for which further adjudication has been stayed pursuant to that Minute Entry filed June 19,
 2 2018. The stayed potential water rights are: 111-19-001-DM001, 113-11-003-DM001, 113-12-
 3 001-DM001 and 113-12-001-DM002. The status of the abstracts for the potential water rights
