DESCRIPTIVE SUMMARY: Telephonic hearing set for **April 15, 2021** at 2:30 p.m. to show cause that Statements of Claimant 39-1089 and 39-1090 shall not be dismissed and no further proceedings undertaken in this case.

At the Status Conference held in this case on October 9, 2020, landowner Sybil Isolde Erden appeared on her own behalf and on behalf of Jeffrey T. Robbins. Ms. Erden stated that she intended to assert water rights to property included within Watershed File Report 113-12-DD-011.

1 In Watershed File Report 113-12-DD-001, Arizona Department of Water Resources
2 (“ADWR”) identified two Statements of Claimant relevant to the land: 39-1089 and 39-1090.
3 Albert S. Duff filed these Statements of Claimant. The public records of ADWR do not include
4 an assignment of the Statements of Claimant to Sybil Isolde Erden or Jeffrey T. Robbins. The
5 public records of ADWR also do not contain Statements of Claimant filed by Sybil Isolde Erden
6 or Jeffrey T. Robbins. Given that five months has lapsed since the Status Conference, it is not
7 clear that either Sybil Isolde Erden or Jeffrey T. Robbins intend to pursue rights to use water on
8 the property.

9 **IT IS ORDERED** that Sybil Isolde Erden or Jeffrey T. Robbins shall appear
10 telephonically on **April 15, 2021** at 2:30 p.m. to provide good reasons that Statements of
11 Claimant 39-1089 and 39-1090 should not be dismissed and no further proceedings undertaken
12 in this case.
