Mr. Crestin reports that ASLD has reviewed Statement of Claimant ("SOC") 39-6728 and will be withdrawing SOC 39-6728.

IT IS ORDERED that SOC 39-6728 is dismissed.

LET THE RECORD REFLECT that a representative for Claimant Paul L. Sale Investment Company is not present or represented by counsel. The Court states that notice was sent to the last known address for Claimant Paul L. Sale Investment Company and the notice has been returned as undeliverable.

IT IS ORDERED removing Paul L. Sale Investment Company from the Courtapproved mailing list.

The Court notes that SOC 39-2224 filed by Paul L. Sale Investment Company has not been assigned and is inclined to dismiss it.

Mr. Foy requests that SOC 39-2224 not be dismissed as that SOC is the subject of one of the other Paul Sale cases, W1-11-2805, in which SRP is the claimant. He states that the order that came out of the last status conference in that case was that SRP was to amend the underlying 36 filing and after doing so, SRP would either amend SOC 39-2224 or file a new SOC. SRP has not made a decision at this point on which direction to proceed.

Mr. Foy further states the SRP is not asserting any claims with respect to this contested case.

The Court will not dismiss SOC 39-2224. There will be no water rights determined that were the subject of WFR 114-01-CCD-011 and no further action will be taken in this case.
