The court notes that a Statement of Claimant was filed by Jose and Rita Morales for water rights that were investigated in Well Report 114-04-BAD-008.

Mr. Calderon states that he is continuing to use the water on this property for domestic purposes. Mrs. Calderon states that her mother, Rosalie Morales, who lives on the property and is Jose and Rita Morales' daughter, uses the water on this property for landscaping use. Mr. and Mrs. Calderon state that they may make a claim for irrigations purposes as well.

Felix Morales, Robert Morales, and Martina Burnham state their claims for domestic use of the water on this property.

The Court informs the parties that they can meet and confer with ADWR and the objectors about this case to determine if the objections could be resolved and the parties could agree on water rights. Alternatively, a date for a scheduling conference could be set which would include a date for a hearing at which time the parties would have the opportunity to put on evidence in support of their claims for water rights.

The parties agree to meet with ADWR regarding the objections to water rights.

Jose and Rita Morales are both deceased. They filed a Statement of Claimant which has not been assigned. The transfer of the Statement of Claimant will be one of the issues at the meeting with ADWR.

IT IS ORDERED that Felix Morales be added to the Court-appointed mailing list. His address is: PO Box 646, Winkelman, AZ 85192. All other parties' mailing information is correct.

IT IS FURTHER ORDERED directing Ms. Parks to set up a meeting before **April 30, 2020** with ADWR, the objectors, and the landowners and/or representatives of the landowners.
