CONFERENCE

CONTESTED CASE NAME: *In re Salt River Project - Irrigation*
HSR INVOLVED: San Pedro River Watershed Hydrographic Survey Report.
DESCRIPTIVE SUMMARY: Scheduling conference set for August 15, 2019 vacated. Salt River Project to file a statement of intent regarding potential water rights.

This case involves potential water rights for irrigation and domestic use identified in watershed file reports 114-04-BDD-001 and 114-04-BDD-029 published in the Final San Pedro River Watershed Hydrographic Survey Report (1991). The parties have entered into a

1 stipulation and submitted proposed abstracts for water rights that the Court approved by Orders
2 dated July 31, 2019. Due to the parties' agreement and the stipulated abstracts, the Scheduling
3 Conference conditionally set for August 15, 2019 will not occur.


4 Additional information is, however, required from Salt River Project Agricultural
5 Improvement and Power District and Salt River Valley Water Users' Association (SRP) to
6 fully resolve the water rights investigated by the watershed file reports. In each case, an
7 abstract was not submitted for a potential irrigation right and with respect to watershed file
8 report 114-04-BDD-029, an abstract was not submitted for a domestic use, but an abstract was
9 submitted for a stock watering use as shown below:
