IT IS ORDERED that David Brown on behalf of landowners, Fred Miller and Julia Pemberton, shall be added to the court-approved mailing list for this contested case W1-11-3323.

Mr. Brown states that this case does have surface water rights affiliated with it. The clients obtain their water from wells. The Court notes that ADWR has determined that the well listed in the WFR is in the sub flow zone.

Mr. Brown indicates that he will file amended Statement of Claimants and proposed Abstracts which will be sent to the objectors for their proposed corrections.

The Court inquires if Mr. Brown has had any contact with Albert Wallace and Katherine Wallace as mail sent to their last known address has been returned. He states he has not.

IT IS FURTHER ORDERED removing Albert Wallace and Katherine Wallace be removed from the Court-approved mailing list.

Discussion is held if the parcel of land owned by William Walker and Penny Walker is included in the land that ADWR mapped as irrigated in the WFR.

Mr. McGinnis requests clarification if the well in question is in the sub flow zone. ADWR has found that Well 01, located on NWSWSE04 07S 17E, is included in the subflow zone.

IT IS FURTHER ORDERED that Mr. Brown shall file by **November 1, 2019** amended Statement of Claimants and proposed Abstracts.
