Sandra Knox addresses the Court and states that she is claiming rights for domestic use. She states that she has prepared abstracts to present to the Court, but has not circulated them to the objectors.

Mr. McGinnis states that he would like to have a meeting with Ms. Knox and Mr. Rubin.

Discussion is held regarding objections. Mr. McGinnis states that he is willing to work with Ms. Knox and Mr. Rubin to address several issues, and states that he will circulate copies of the abstracts that Ms. Knox prepared to the objectors and to counsel.

IT IS ORDERED that by **January 31, 2020** Ms. Knox shall file either the proposed abstracts to which all of the objecting parties have agreed or file a report with the Court if not all of the objecting parties have agreed to her proposed abstracts.

The Court informs Ms. Knox that if all of objectors do not withdraw their objections and agree to her rights for domestic water use, the next step in the process will be to set a scheduling conference and a hearing date to determine water rights.

Mr. McGinnis will assist Ms. Knox and Mr. Rubin by organizing a telephone call among all of the parties to discuss the objections to their claims.
