DESCRIPTIVE SUMMARY: No water rights will be adjudicated for water uses investigated by watershed file report 115-05-DB-002.

This consolidated case was initiated to resolve objections to seven watershed file reports, including watershed file report 115-05-DB-002. Watershed file report 115-05-DB-002 was

1 initially the subject of contested case W1-11-3401 that was consolidated with this contested case  
2 W1-11-3326.

3 Arizona Department of Water Resources identified potential water rights in watershed  
4 file report 115-05-DB-002 for irrigation and stock watering uses in the SWNE Section 26 T7S  
5 R19E. On July 11, 2019, the trustees of the Lackner Living Trust and the Arizona State Land  
6 Department, the Claimants, jointly filed a notice that neither party intended to pursue water  
7 rights for either use described in watershed file report 115-05-DB-002.  
8

9 **IT IS ORDERED** that no water rights will be adjudicated based on the potential water  
10 rights identified in watershed file report 115-05-DB-002 and no further action will be taken with  
11 respect to watershed file report 115-05-DB-002 or the claims for water rights that were the  
12 subject of watershed file report 115-05-DB-002.

13 **IT IS FURTHER ORDERED** vacating the order requiring the filing of any suggested  
14 corrections to the proposed abstract for 115-05-DB-002-SW001.
