Discussion is held regarding the status of the Statements of Claimant (SOCs) that have not been assigned from the original claimants to the current landowners.

A Statement of Claimant was filed by Jan Rogers and Larri Tearman's grandmother, Delta Bryce, who is now deceased. Delta Bryce's daughters, Greta Bergen and Logene Allen are also deceased, but an assignment of statement of claim was not made into either of their trusts. The granddaughters of Delta Bryce, Jan Rogers and Larri Tearman, have not assigned the SOC into the proper trusts.

Kimberly Parks reports that she may be able to assist Jan Rogers and Larri Tearman in resolving this problem. Ms. Parks shall review all documents provided by the trustees of the Greta Bergan Trust and Logene Allen Trust (deeds and trust documents) to determine the best way to proceed.

Jan Rogers as trustee and Larri Tearman as a representative of the trustee state that they intend to pursue a claim for water rights for the land held in trust.

IT IS ORDERED that by **October 15, 2019** ADWR shall schedule and hold a meeting with the representatives of the trustees and the trustees of the Greta Bergan Trust and Logene Allen Trust and the Objectors to determine if the objections to the potential water rights set forth in Watershed File Report 115-05-AC-007 can be resolved.
