The Court notes that there are two claims for water rights: domestic and stock watering use.

Ms. Dworkin reports that her client is abandoning his claim for irrigation and all that is remaining are claims for stock watering and domestic uses.

The Court states that it cannot issue a proposed abstract using the procedures for *de Minimis* water rights because the water amounts claimed for domestic use are greater than one-acre foot. Discussion is held regarding the stock watering use.

The Court suggests that Ms. Dworkin circulate the proposed abstracts amongst the parties and see if they are willing to stipulate to the proposed abstracts and withdraw their objections.

Mr. Foy and Mr. Gehlert state their client's prospective positions.
