LATER

The Hopi Tribe moved to brief priority issues in *In re Navajo Nation* as a scheduling proposal intended to move the litigation in the Little Colorado River Watershed forward during the period for which it requested a stay the current and future phase of *In re Hopi Reservation HSR*. To date, requested stays of the hearing have been denied. In its reply the Hopi Tribe suggested a number of issues that should be the subject of a focused motion practice to occur simultaneously with a trial expected to continue for more than four months. Given that the *In re Navajo Nation* has already been divided into three phases, each of which will provide opportunities to conduct the discovery, no reason exists to create a fourth phase that will simply result, as counsel for Navajo Nation has represented, in requests for relief under Ariz. R. Civ. P. 56(d).

IT IS ORDERED denying the Hopi Tribe's Cross-Motion to Commence Priority Briefing.
