

4 033-51-DAB-001 prepared by the Arizona Department of Water Resources, *In re Arizona Game*  
5 *& Fish Department* must be separated from this contested case.

6 **IT IS ORDERED** that contested case *In re Arizona Game & Fish Department*, CV 6417-  
7 33-6376 shall be separated from this contested case and all future filings for *In re Arizona Game*  
8 *& Fish Department* shall be filed under case number CV 6417-33-6376.

9 **IT IS FURTHER ORDERED** that any stay imposed in this case is vacated with respect  
10 to *In re Arizona Game & Fish Department* CV 6417-33-6376.
