On April 20, 1994, the Special Master issued a Memorandum Decision, Findings of Fact, and Conclusions of Law for Group 1 Cases Involving Stockponds, Stockwatering, and Wildlife Uses (“Decision”) that recommended rules and procedures to adjudicate *de minimis* water uses in the Silver Creek watershed. Abstracts for proposed water rights involved in the first group were also prepared and attached to the Decision. To date, no further action has been taken with respect to either the Decision or the Abstracts.

1 A Status Conference will be held to address the action necessary to conclude the process
2 of determining the applicability of *de minimis* procedures for the adjudication of claims for
3 water rights for stockponds and stock and wildlife watering in the Silver Creek watershed.
