AGFD is working with the objectors to file a stipulation as to issues stated in the WFR.

The United States is currently reviewing the abstract and map.

Mr. Crestin requests time to work with the objectors.

The AGFD has to approve the stipulation prior to it being filed, and their next meeting is on November 8, 2024.

Mr. Cresting requests one week to finalize a stipulation of the parties and requests the deadline to be **November 15, 2024**.
