The Court requests that counsel for the Arizona State Land Department create a new exhibit with the identified pages from Hopi Exhibit 4586 and provide it to counsel and the clerk.

The witness is excused.

Counsel for Hopi Tribe informs the Court that on December 15, 2020 (trial day 38), LCR exhibits 1469, 1470 and 1150 were admitted in evidence but are not referenced in the minute entry.

## LATER:

Hopi Exhibit 4586 consists of a more than 250 pages of maps created by a consulting firm. The exhibit was not included on the Hopi Tribe's exhibit list. The parties did not object to the use of designated pages of Hopi Exhibit 4586 for demonstrative purposes while the witness testified. The parties did not object to the admission of the exhibit as evidence. Several parties argued that foundational issues existed related to the data shown on the map. The objection has merit.

Hopi Exhibit 4586 is not admitted into evidence for any purpose and any order included in this minute entry admitting identified pages of Hopi Exhibit 4586 is revoked. Instead, to avoid confusion that could result from admitting only selected pages of an

exhibit, the Arizona State Land Department was instructed to compile the designated pages of Exhibit 4586 into a new exhibit, circulate those pages to the parties, and submit the new exhibit to the clerk. The exhibit, newly created by ASLD, will be admitted solely as a demonstrative exhibit to show the locations of the land described by township and range referenced in Mr. Lowman's testimony and report.
