Discussion and protocol is held regarding the upcoming site visit to the Hopi Nation.

Mr. Campbell confirms that the Hopi Nation is ready to move forward with the site visit as planned and further advises the Court and counsel that they will be meeting at the Tuuvia Travel Center. Mr. Campbell further advises that there is a schedule prepared for both days of the site visit. Max Taylor, who works for the Hopi water department, will be leading the site visit.

The Court confirms that Court will comply with the Covid mandates the Hopi Tribe has in place.

Mr. Leonard questions the reasons and need for the proposed visit as evidence is closed and the trial is over. He also questions what Covid protocols are currently in place on the Hopi Reservation.

Brad Pew will be attending on behalf of the LCR Coalition has no objections to the trip but would like confirmation that any information obtained during the site visit won't become part of the record in this matter and that the protocols earlier agreed upon by the parties will be in effect.

The Court confirms that no information from the site visit will be treated as additional evidence to be considered in this matter.

Ms. Ross has no objections and agrees with the suggested protocols.

Mr. Weldon will be attending the visit on the trip on behalf of SRP. Mr. McGinnis said that if possible if his trial scheduled for the following week does not proceed, he would also like to attend the site visit.

Ms. Brennan questions if a 4-wheel drive vehicle is required and asks about the lodging at the Hopi Cultural Center. Mr. Campbell said that a 4-wheel drive vehicle is not necessary.

Mr. Campbell confirms that rooms are reserved for counsel.

Ms. Storey shares the previously discussed Covid concerns. She questions the provision of any lay testimony that may occur during the visit and also agrees that it should not be considered as additional evidence in this matter.

Mr. Campbell confirms that the case cannot be discussed during the visit.

Lunch and dinner plans are briefly discussed.

Mr. Leonard continues to object to the need for the onsite visit given the Covid pandemic.

There are no further objections from counsel.

IT IS ORDERED affirming the onsite visit of the Hopi Nation to begin at <u>8:00</u> <u>a.m. on September 9, 2021.</u>
